COURSE DESCRIPTION & OVERALL GOAL

The purpose of this training is to strengthen providers' knowledge of TB diagnosis, treatment, and management. The conference will provide an opportunity to discuss current and emerging issues in TB, as well as perspectives for the resolution of challenges in the management of complex TB cases. Topics will include local epidemiology, the diagnosis and treatment of TB infection, managing drug resistant TB, refugee health and TB, regional resources and a panel discussion of health department services. The format will include a combination of lectures and panel discussions.

WHO SHOULD ATTEND

This conference is designed for healthcare providers who are involved in the diagnosis, treatment and management of persons with latent TB infection and disease. Physicians, physician assistants, nurse practitioners, public health nurses, and others working in TB control are welcome to attend.

WHY COURSE IS NEEDED

As the incidence of TB continues to decline, maintaining clinical expertise is particularly challenging especially as the cases are more complex to diagnosis and manage. Ongoing training and education are important for healthcare workers so they can develop and enhance skills in the diagnosis of TB, follow recommended treatment guidelines, and interact effectively with public health agencies.

OBJECTIVES

Upon completion of this conference, participants should be better able to:

- Interpret local and global epidemiological trends to better screen and treat groups at high risk for tuberculosis;
- Apply current recommendations for assessing risk, testing and treating TB infection to prevent development of disease
- Integrate principles for the diagnosis, treatment and management of TB disease to prevent transmission and drug resistance
