The format includes lectures, discussions, and case studies.

WHO SHOULD ATTEND

This conference is intended for physicians practicing Primary Care, Infectious Diseases, Pulmonary and Emergency Medicine. Physician Assistants and Nurse Practitioners are also welcome to attend.

WHY COURSE IS NEEDED

As the incidence of tuberculosis continues to decline, maintaining clinical expertise in TB is particularly challenging. Therefore, ongoing training and education are important for clinicians so they can develop and enhance skills in the diagnosis of TB, follow recommended treatment guidelines, and interact effectively with public health agencies.

- Integrate the treatment of TB disease in HIV infection to provide accurate diagnosis and effective treatment in co-infected patients
- Describe genotyping and interpret results in order to identify TB transmission and outbreaks
- Explain the relationship between TB and diabetes, and apply current recommendations for proper diagnosis and treatment of TB in patients with diabetes
- Utilize current recommendations for screening, diagnosis, and treatment of latent TB infection and TB disease in patients taking TNF-alpha inhibitors in order to avoid development of complications related to the development of TB in those infected and the cure of active TB disease
- Apply current standards of practice in the medical management of tuberculosis in pregnant women to provide cure and prevention of adverse effects
- Summarize new research about TB and relate it to current clinical practice
- Critique different diagnostic tests for TB and implement in current clinical practice where appropriate
- Discuss challenges in working with homeless patients and choose appropriate strategies to ensure completion of treatment
