Dr. Barry Kreiswirth is Director of the TB Center at the Public Health Research Institute (PHRI) and a Professor of Medicine at UMDNJ – New Jersey Medical School. He also has an adjunct faculty position in the Department of Medicine at New York University and at the Mailman School of Public Health at Columbia University. The PHRI TB Center was established in 1992 at the initiation of Dr. Kreiswirth in response to the emerging epidemic of tuberculosis in New York City. DNA fingerprinting techniques that were in part developed and refined at the Center were used to identify the highly drug-resistant "W" strain of TB as a major cause of the NYC epidemic. Over the past decade, the Center has collaborated with the Centers for Disease Control and Prevention, the New York City Department of Health and Mental Hygiene, the New Jersey Department of Health and Human Services, the New York State Department of Health - Wadsworth Center, and global agencies in Russia, South Africa, Tanzania, Egypt, the Czech Republic, and India to genetically characterize and catalogue thousands of clinical *M. tb* isolates. Under Dr. Kreiswirth's direction, the Center's work in genotyping drug resistance has made it possible to define drug resistant strains in days rather than weeks and improve the accuracy and speed of drug susceptibility testing. Dr. Kreiswirth has extensively published on genotyping techniques and his work continues to advance the study of molecular epidemiology with domestic and global implications for TB control and prevention.
